Synopsis

There are significant changes / updates on requirement and rules on electrical installations of buildings complying with MS IEC (IEC) 60364 Electrical Installations for Buildings. For example, the mandatory Non -Domestic Electrical Installation Safety Code which was registered on 17th May 2017 by the Energy Commission, in exercise of the Power conferred by Section 50A of the Electricity Supply Act 1990 [Act 447], has a significant clarification on earthing system. This talk shall provide an overview of these requirement and rules on electrical installations of buildings.

- Committee member of Electrical Engineering Technical Division, IEM

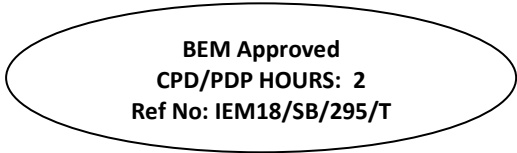
