The adoption of Building Information Modelling (BIM) requires organizations and individuals to change the way they work. The traditional roles within the supply chain and client organizations may need to be redefined to successfully implement the new processes and information management requirements of BIM. This approach offers multiple benefits including faster, safer and ultimately more efficient solutions for clients. It is relevant for the majority of organizations working in the architectural, engineering, construction and infrastructure sectors, whatever their size, as well as contractor's clients who require their supply chain to use BIM processes and tools.
